Hospital Office: Inpatient Site at 200 High Park Ave., Goshen, IN 46526. Enter through the main entrance of Goshen Hospital. Follow the signs for Goshen Rehabilition. Maps and volunteers are available at the front entrance for assistance. Questions? Call (574) 364-2606.

Goshen Office: College Ave to Dierdorff/CR 27. Turn south onto Dierdorff/CR 27, proceed around the roundabout and then turn left onto Berkshire Drive. Nappanee Office: Outpatient site at 1953 Waterfall Dr., Suite B, Nappanee, IN 46550. SR 19 South to US 6 East. From US 6 turn north on Country Road 7/Oakland Avenue. Approximately ¾ of a mile on the east side of the road is Waterfall Drive. Turn right on Waterfall Drive and follow that around to the right.
